## Contributors

**James S. Amelang** is Professor of Early Modern History at the Universidad Autónoma of Madrid. The author of several works on the social and cultural history of early modern Barcelona, most recently he has published *The Flight of Icarus: Artisan Autobiography in Early Modern Europe* (1998). He is presently preparing a general history of early modern Spain, and for the more distant future, plans to work on aspects of the history of urban discourse in early modern Europe.

**Karl Appuhn** is an Assistant Professor in the History Department at New York University. His research is primarily concerned with the environmental history of the Renaissance, with a particular focus on the political, economic, and intellectual dimensions of human attempts to control nature. He has written articles about forest management and land surveying in Renaissance Venice. He is currently working on a history of flood control in Venice.

**Thomas F. Arnold** is program manager with the Alliance for Lifelong Learning, a not-for-profit online educational joint

project of Oxford, Stanford, and Yale Universities. From 1993 to 2001 he was Assistant Professor of History at Yale, where he taught Renaissance Italy. His specialty is military history, and particularly the possibility that Renaissance Europeans invented a new military culture that continues to shape warfare down to the present.

**Gene Brucker** is Professor Emeritus at the University of California, Berkeley. Among his many books on medieval history and the Renaissance are *Renaissance Florence* (1969, 1983), and *Giovanni and Lusanna: Love and Marriage in Renaissance Florence* (1986).

**Peter Burke** is Professor of Cultural History, University of Cambridge, and Fellow of Emmanuel College. He has been publishing studies of the Renaissance for nearly forty years, including *Culture and Society in Renaissance Italy* (1972, fourth edition 2001), *The Renaissance* (1987, second edition 2000) and *The European Renaissance* (1998). His current research interests include the social history of language and he is



working on a comparative study, provisionally entitled *Languages and Communities in Early Modern Europe*.

**Linda T. Darling** is Professor of History at the University of Arizona, where she has taught Middle Eastern history since 1989. Her current research interests include an examination of provincial fiscality in the seventeenth century and its impact on provincial politics, taking Syria-Lebanon as a case study.

**William Eamon** is Professor of History and director of the University Honors Program at New Mexico State University, where he teaches courses on the history of science and medicine and on early modern history. He is the author of *Science and the Secrets of Nature: Books of Secrets in Medieval and Early Modern Culture* (1994; Italian translation 1999) and about forty articles on various themes relating to the history of science, medicine, and magic. He is currently completing a book titled *The Charlatan's Tale: A Renaissance Surgeon's World*.

**James R. Farr** is Professor of History at Purdue University. He received his PhD from Northwestern University in 1983, served as Editor of *French Historical Studies* from 1991–2000, and is the author of three books, *Hands of Honor: Artisans and Their World in Dijon, 1550–1650* (1988), *Authority and Sexuality in Early Modern Burgundy, 1550–1730* (1995), and *Artisans in Europe, 1300–1914* (2000).

**Joanne M. Ferraro** is Professor of History at San Diego State University. A specialist in the history of marriage, family, and gender in early modern Italy, she is the author of *Family and Public Life in Brescia, 1580–1650*, *The Foundations of Power in the Venetian State* (1993), and *Marriage Wars in Late Renaissance Venice* (2001).

**David C. Gentilcore** is Reader in History, Department of History, University of Leicester. He is interested in the social and cultural history of early modern Italy, in particular the (often strained) relationship between beliefs and practices at different levels of society. He is the author of *From Bishop to Witch: the System of the Sacred in Early Modern Italy* (1992) and *Healers and Healing in Early Modern Italy* (1998), and is currently preparing a study of medical charlatanism.

**Gregory Hanlon** is Professor of History at Dalhousie University in Halifax, Canada. He is author of *L'Univers des gens de bien: Culture et comportements des élites urbaines en Agenais-Condomois au XVIIe siècle* (1989), *Confession and Community in Seventeenth-century France: Catholic and Protestant Coexistence in Aquitaine* (1993), *The Twilight of a Military Tradition: Italian Aristocrats and European Conflicts, 1560–1800* (1998), and *Early Modern Italy, 1550–1800: Three Seasons in European History* (2000). He is currently researching a book called *Peasant Lives in Rural Tuscany: Human Nature in Historical Time, 1610–1670*.

**R. Po-chia Hsia** is Edwin Earle Sparks Professor of History at Pennsylvania State University. He previously taught at Columbia, Cornell, University of Massachusetts, and New York University. He has received fellowships from the United States and Germany, and has held visiting professorships and research positions in Germany and the Netherlands. Elected in 2000 to the Academia Sinica (Taiwan), he is currently researching the history of Sino-European relations from the 16th to the 18th centuries. His books include *Society and Religion in Munster 1535–1618* (1984), *Social Discipline in the Reformation: Central Europe 1550–1750* (1989),

and *The World of Catholic Renewal 1540–1770* (1998).

**Mary Lindemann** is Professor of History at the University of Miami. She is a specialist in the history of seventeenth- and eighteenth-century Europe, in particular Germany and the Low Countries, and in the history of medicine. Her publications include *Patriots and Paupers: Hamburg, 1712–1830* (1990), *Health and Healing in Eighteenth-Century Germany* (1996), and *Medicine and Society in Early Modern Europe* (1999).

**John A. Marino** is Associate Professor of History at the University of California, San Diego. He is the author of *Pastoral Economics in the Kingdom of Naples* (1988). He is the editor of *Early Modern Italy, 1550–1796* (2002), *Early Modern History and the Social Sciences: Testing the Limits of Braudel's Mediterranean* (2002), and has co-edited/co-translated *Good Government in Spanish Naples* (1990). He specializes in the early modern history of Naples, Spanish Italy, and the Mediterranean.

**John Jeffries Martin**, is Professor of History at Trinity University, where he teaches courses on medieval and early modern Europe. He is the author of *Venice's Hidden Enemies: Italian Heretics in a Renaissance City* (1993) and the editor of *The Renaissance: Italy and Abroad* (2002). He is currently writing a book on the history of sincerity and constructions of the individual in western Europe from the Renaissance to the Enlightenment.

**Ian Frederick Moulton** is Associate Professor of English at Arizona State University West. He is the author of *Before Pornography: Erotic Writing in Early Modern England* (2000), a study of the representation of sexuality and

gender in 16th century England and Italy, as well as a number of articles on early modern literature and culture. He is currently preparing a translation of *La Cazzaria*, an erotic academic dialogue from Renaissance Italy.

**Robert Muchembled** is Professor of History at the University of Paris North. He is project co-ordinator for the ESF program *Cultural Exchange in Europe 1400–1700*, and author of numerous books and articles. These include *Culture Populaire* (1978) and *History of the Devil* (forthcoming).

**Edward Muir** is the Clarence L. Ver Steeg Professor in the Arts and Sciences and a member of the History Department at Northwestern University. He is the author of *Civic Ritual in Renaissance Venice, Mad Blood Stirring: Vendetta in Renaissance Italy*, and *Ritual in Early Modern Europe*. He co-edited with Guido Ruggiero three volumes of articles translated from the Italian journal, *Quaderni Storici*. He is currently engaged in a study of the forms of neighborly trust in Italian Renaissance communities.

**John M. Najemy** is Professor of History at Cornell University. His chief research interests have been in the political and intellectual history of Renaissance Florence. He is the author of *Corporatism and Consensus in Florentine Electoral Politics, 1280–1400* (1982), *Between Friends: Discourses of Power and Desire in the Machiavelli-Vettori Letters of 1513–1515* (1993), and essays on Florentine political thought, civic humanism, Machiavelli, and Alberti. He is currently writing a history of Florence from 1250 to 1555 (forthcoming) and editing a volume on the Renaissance.

**Loren Partridge** is Professor of Art History and Italian Studies at the University

of California, Berkeley where he has taught Italian Renaissance art and architecture for over thirty years. Recent books include (with Randolph Starn) *Arts of Power: Three Halls of State in Italy 1300–1600* (1992), *The Renaissance in Rome* (1996), *Michelangelo: The Sistine Chapel Ceiling, Rome* (1996), and *Michelangelo; The Last Judgment: A Glorious Restoration* with contributions by F. Mancinelli and G. Colalucci (1996). He is currently writing a monograph on the Villa Farnese at Caprarola, and a general survey of Italian Renaissance art.

**Matthew Restall** is Professor of Colonial Latin American History and Women's Studies and Director of Latin American Studies at the Pennsylvania State University. His publications, which focus mostly on the history of colonial Yucatán, include *The Maya World: Yucatec Culture and Society, 1550–1850* (1997) and *Maya Conquistador* (1998). His new book, *Seven Myths of the Spanish Conquest*, comes out this year, and he is currently writing a study of Africans in colonial Yucatán.

**Ingrid D. Rowland** is Andrew W. Mellon Professor in the Humanities at the American Academy in Rome. She is author of *The Culture of the High Renaissance: Ancients and Moderns in Sixteenth-Century Rome* (1998), *The Ecstatic Journey: Athanasius Kircher in Baroque Rome* (2000), *The Correspondence of Agostino Chigi* (2001), and translator of *Vitruvius' Ten Books on Architecture* (1999). She is currently writing a biography of the southern Italian philosopher Giordano Bruno.

**Guido Ruggiero** is Professor and Chair of the History Department at the University of Miami. His previous publications include *Binding Passions: Tales of Magic Marriage and Power at the End of the Renaissance* (1993), *The Boundaries*

*of Eros: Sex Crime and Sexuality in Renaissance Venice* (1985) and *Violence in Early Renaissance Venice* (1980). He has also edited two series of books: *Studies in the History of Sexuality* and *Selections from Quaderni Storici*. In addition he has co-edited and co-translated with Laura Giannetti *Five Comedies from the Italian Renaissance* (2003).

**Randolf Starn** is Professor of History and Italian Studies, currently Director of the Center for Italian Studies, at the University of California, Berkeley. He has taught and written extensively on Renaissance Italy and the history of Renaissance culture. A collection of his essays, *Varieties of Cultural History*, will appear in 2002.

**James Grantham Turner** is Professor of English at the University of California, Berkeley. He has published numerous articles on literature, art, and culture from the 16th to the 18th centuries, and edited a volume of essays on Renaissance sexuality and gender. His books include *One Flesh: Paradisal Marriage and Sexual Relations in the Age of Milton* (1987, 1993), *Libertines and Radicals in Early Modern London: Sexuality, Politics and Literary Culture, 1630–1685* (2001), and *Schooling Sex: Libertine Literature and Erotic Education in Italy, France, and England, 1534–1685* (forthcoming).

**Matthew Vester** is Assistant Professor of History at West Virginia University. He received his PhD in 1997 from the University of California, Los Angeles. He has published articles on early modern fiscal politics and is completing a book manuscript on political culture (institutions, informal political networks, representations of power, and local political associations) in the sixteenth-century Savoyard states. A second area of his research examines interactions between

villages, state officials, municipalities, and the feudal nobility in the late Renaissance alpine duchy of Aoste/Aosta.

**Elissa B. Weaver** is Professor of Italian at the University of Chicago. Her research interests include Italian medieval and early modern literature, women's literature, Renaissance theater and epic-chivalric poetry. She is author of *Convent Theatre in Early Modern Italy: Spiritual Fun and Learning for Women* (2002) and editor of *Francesco Buoninsegni and suor Arcangela Tarabotti, Satira Antisatira* (1998), *Beatrice del Sera, Amor di virtù, commedia in cinque atti (1548)* (1990).

**Linda Woodbridge**, Distinguished Professor of English at Pennsylvania State University since 1994, she previously taught at the University of Alberta for 24 years, where she chaired the English department. Her books include *Women and the English Renaissance: Literature and the Nature of Womankind, 1540–1620* (1986), *The Scythe of Saturn: Shakespeare and Magical Thinking* (1994), and *Vagrancy, Homelessness, and English Renaissance Literature* (2001). She has served as president of the Shakespeare Association of America. In 2001–2002 she is a long-term fellow at the Folger Shakespeare Library in Washington, DC.
